Ind-Expo Certification Limited ISO 22000:2005 Transition Policy

ISO 22000:2018 has been updated to replace the existing quality standard ISO 22000:2005. Organizations will no longer be able to continue to be certified to ISO 22000:2005 from the 19th of June 2021.

Ind-Expo Certification Limited is accredited to certify organizations to ISO 22000:2005 and aims to be in a position to offer accredited ISO 22000:2018 certifications by September 2018. The organization has embarked on an internal transition process in order to realize this objective. All auditors and technical experts involved in the certification process should undergo the E-learning transition training for the ISO 22000:2018 at Ind-Expo Certification Limited to participate audits for the same.

In line with our internal transition process we intend to transition our existing ISO 22000:2005 client's certifications to ISO 22000:2018 within an agreed timescale commencing on 19th June 2018 until the 19th of June 2021. Therefore, Ind-Expo will discontinue the transitions from the ISO 22000:2005 to ISO 22000:2018 on 19th June 2020.

Ind-Expo Certification Limited has created this policy document to clarify the ISO 22000:2005 and ISO 22000:2018 certification process for current and future clients.

ISO 22000:2005 certifications will not be valid three years from publication of ISO 22000:2018. The expiry date of certifications to ISO 22000:2005 issued during the transition period needs to correspond to the end of the three-year transition period.

While ISO 22000:2005 is similar in parts to ISO 22000:2018 there are some additional requirements that clients will have to meet before their Food Safety Management System can be deemed to be compliant with the ISO 22000:2018 standard.
